This Joint Training Seminar will be held on Saturday, July 27, 2013, and will commence at 9:30 AM and end at 12:30 PM and is open to all styles and schools. Following the Joint Training Seminar Burgers & Dogs and bottled water will be provided to participants and family (who pre-register).

This joint training seminar is designed to allow students from different schools and from different martial disciplines to train together in a non-competitive environment and learn from top instructors from different martial art disciplines. We ask that all pre-registration applications be mailed in to HMAG bearing a postmark no later than June 30, 2013. Also include the number of family/friends that will be joining in the post-seminar Burger & Dogs get-together.

The pre-registration cost is \$10.00 per person. The \$10.00 covers the Beach and Pavilion rental, food and bottled water following the seminar. The pre-registration form will assist us in getting an accurate head count for ordering Burger & Dogs. Late registrations will be accepted at the door from 8:30 to 9:30 AM, and subject to space available. Late registration will be \$10 per person, includes post training get-together.
